PURPOSE OF POSITION

The Aboriginal Project Coordinator will play a central role in the ISAAC (Invasive Streptococcus A: Antibiotic prophylaxis for Contact management) Trial. This is a 5-year national NHMRC-funded study investigating how best to prevent invasive Group A Strep (iGAS) among people living with someone diagnosed with iGAS.

This position is important to ensuring Aboriginal leadership, representation, and cultural safety across the project. Based at The Kids Research Institute Australia, and also working closely with the University of Melbourne, the Aboriginal Project Coordinator will guide and support the study coordinators across Australia, with a strong focus on Aboriginal engagement and governance. This includes overseeing Aboriginal-specific ethics submissions, co-designing culturally appropriate materials, building relationships with communities and referral sites, and leading the development of educational resources related to iGAS.
